

## **Practice Experience**

*The students need to certify that they have been practicing Yoga (Vinyasa Flow, Ashtanga, Power or Similar) seriously 3-4 times a week for a minimum of two years (self practice and Videos acceptable).*

## **Teacher training course?**

*In order to reserve your place we require initial deposit of €200 when you register. Once you confirm your participation, you will receive an invoice. Two months prior the training a second deposit of the cost of your chosen accommodation is due. The remaining balance of €1800 can be paid anytime before the start of the training.*

*Tuition cost (Including VAT and Training Manual) – €2000*
